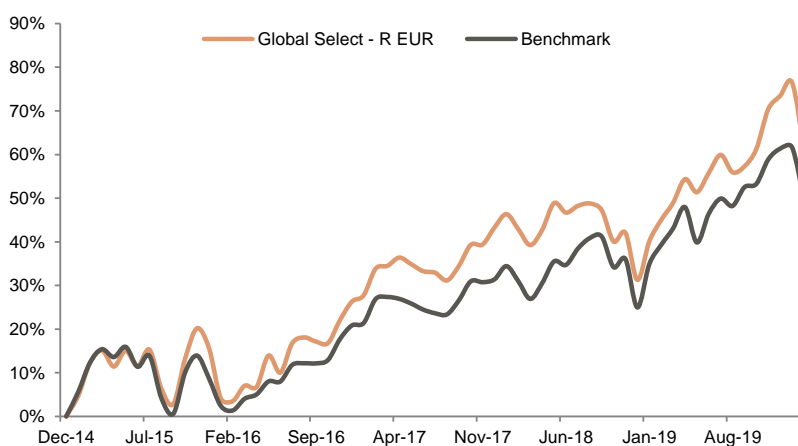

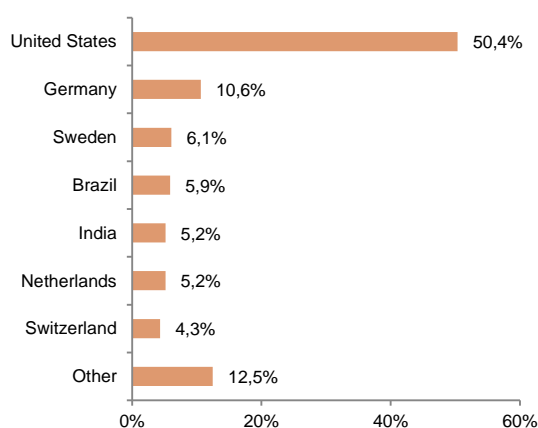

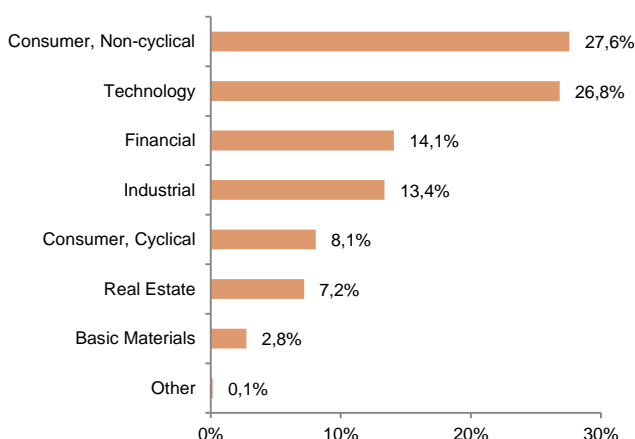

Country allocations



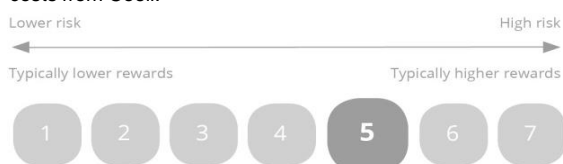
Sector allocations
