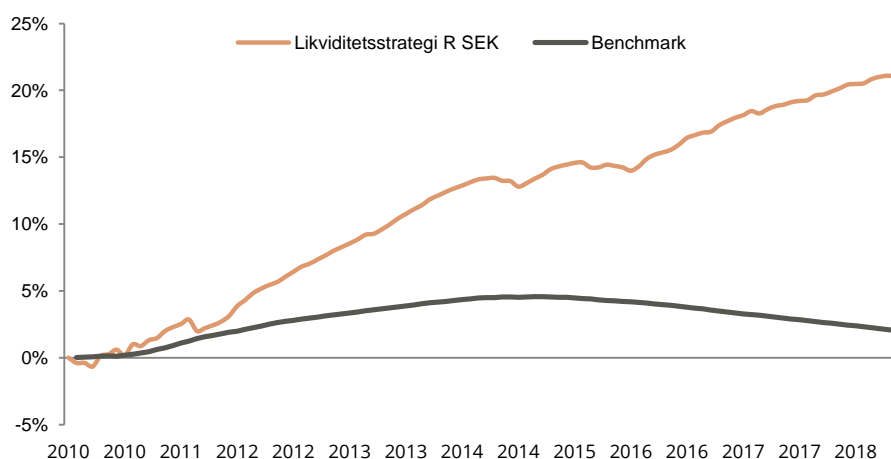

The fund offers investors exposure to a diversified portfolio with a balanced credit risk and a minimum of interest rate risk. Investments are preceded by fundamental company analysis, with emphasis on the companies' business models and their ability to deliver stable profitability.

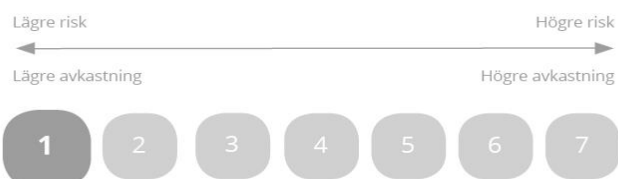
