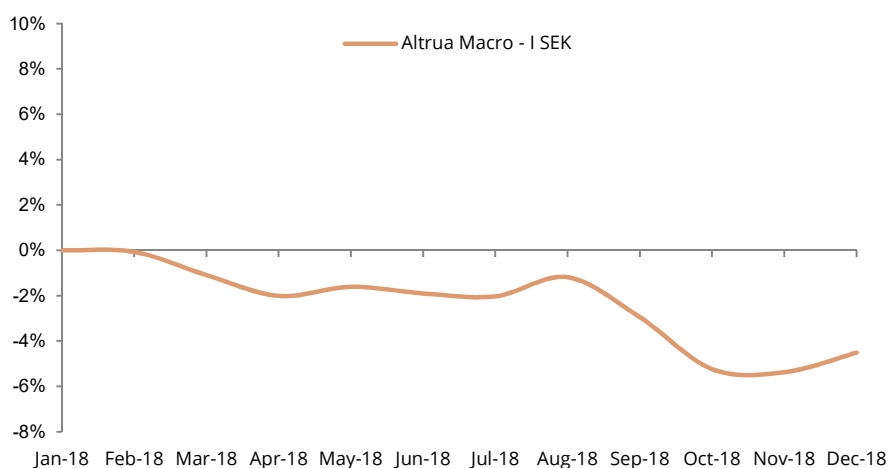

### Summary of Investment Objective

The Altrua Macro Fund applies a quant fundamental framework to construct a core macro asset portfolio which is combined with non-linear strategies in thematic opportunities and tail-risk hedging. Instruments traded in the fund are exchange-traded futures and options, exchange traded funds (ETFs), OTC forwards on underlying exposure to stock and sector indices, fixed income (bonds and short-term interest rates), foreign exchange as well as volatility indices. The fund may invest in money market instruments and highly rated sovereign T-bonds as a part of its cash management strategy.

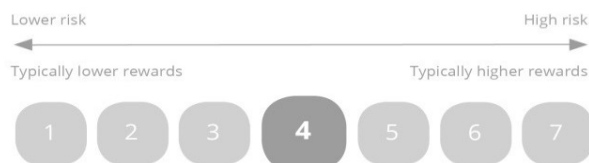
