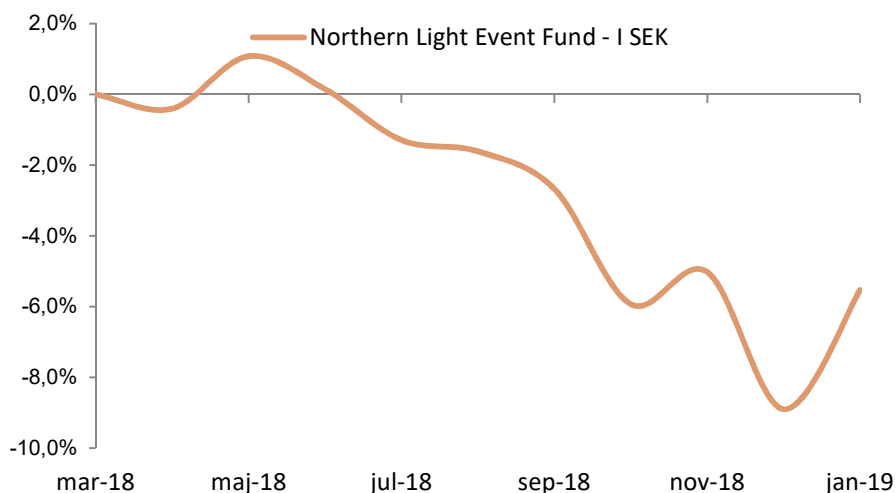

Northern Light Event Fund has an event driven market neutral investment strategy. The Fund deals solely in the equity of U.S.-listed companies undergoing a change of ownership. Changes of ownership typically occur through secondary equity offerings or block trades. The fund's strategy is designed to take advantage of the inefficiency that arises when the stock market overreacts to such changes.

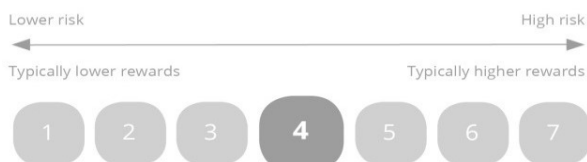
