What is this product?

Type

This is an investment fund established as a Company With Variable Capital (SICAV).

Objectives

Coeli SICAV I – Frontier Markets Fixed Income Fund aims to achieve a competitive return investing in Frontier Markets being markets among the least developed emerging markets.

Investment policies The Investment Manager will invest in hard currency debt securities (typically denominated in USD), hard currency corporate debt and local currency debt securities (Local currency debt securities are fixed income instruments issued by sovereigns, supra-nationals and/or multilaterals in the Frontier Market's own currencies) and derivative financial instruments. Derivative instruments will mainly be used for hedging purposes and for investment purposes only on an ancillary basis.

The Sub-Fund is authorized to use such financial techniques and instruments i.e. for the purpose of hedging and/or efficient management of the portfolio.

Benchmark uses The Sub-Fund is managed actively and uses the JP Morgan NEXGEM Index (Next Generation Markets Index) as a universe to select securities from and to compare performances. The deviation of the portfolio composition of the Sub-Fund compared to the benchmark is significant.

Redemption and Dealing The Sub-Fund will be open for subscriptions and redemptions all official Luxembourg working days under the condition that the London Stock Exchange is open. When the London Stock Exchange is closed, the fund unit value (NAV) will not be calculated.

Distribution Policy The Sub-Fund does not distribute dividends. All income is reinvested in the Sub-Fund.

Launch date The Sub-Fund was launched on 26/03/2021. This share class was launched on 05/10/2021.

Fund Currency The reference currency of the Sub-Fund is USD and the currency of the share class is EUR.

Switching between Funds Investors may switch their shares in the Sub-Fund for shares in another sub-fund within Coeli SICAV I. Intended retail investor

This product is intended for investors who plan to stay invested for at least 3 years and are prepared to take on a medium level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The PRIIP manufacturer, Waystone Management Company (Lux) S.A., is not entitled to terminate the product unilaterally.

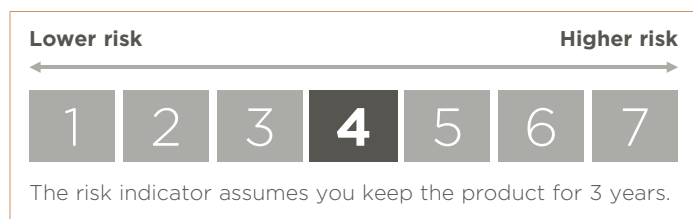

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that

the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Sub-Fund to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

What happens if Waystone Management Company (Lux) S.A. is unable to pay out?

The Management Company has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should the Fund default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

This product is designed for longer term investments; you should be prepared to stay invested for at least 3 years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. The Sub-Fund will be open for subscriptions and redemptions all official Luxembourg working days under the condition that the Swedish market is open. When the Swedish market is closed, no NAV will be calculated.
